

1. <u>Set Agenda</u>

Todd Pierceall, MPO Board Chair asked for a motion to set the agenda as presented or any recommended agenda modifications.

Mr. Humphries motioned to set the Agenda as presented. Mr. Sparrow seconded and the motion was passed unanimously.

2. <u>Determination of Quorum and Good Standing</u>

Ms. Gates verified that a quorum had been met.

3. Approval of Minutes

Mr. Pierceall opened for a motion to approve the March 23, 2017 meeting minutes as presented.

Mayor Beam motioned to approve the March 23, 2017 meeting minutes as presented. Mr. Fraley provided a second to the motion and the minutes were approved unanimously.

4. Introduction of Members & Guests

Mr. Pierceall asked everyone to introduce themselves.

5. Public Comment

Mr. Pierceall opened the floor to public comments and the following comments were received:

- Mr. Walker thanked the Board for their support of the Build a Better Boulevard and the I-85 widening project. Mr. Walker also thanked Mr. John Pope from The NCDOT Board of Transportation for coming to the meeting.
- Representative Bumgardner mentioned that the US 29/74 Bridge replacement needed a closer look. He mentioned that NCDOT has been performing maintenance on the bridge since its construction in 1933. Maintenance can only go so far!
- Mr. Will Neuman thanked the Board for its support of the Catawba Crossings project.

CONSENT AGENDA

6. 2016-2025 MTIP Additions/Modifications

Ms. Gates presented the STIP amendments for the GCLMPO area that were approved by the NCDOT Board of Transportation (BOT) at its April and May 2017 meetings.

Mr. Toomey motioned to approve both a formal/major (R-5849) and minor administrative (M-0521) amendment to the Metropolitan Transportation Plan (MTP). Mr. Humphries seconded the motion and the motion passed unanimously.

7. MPO Board Bylaws Amendment

Mr. Graham explained the proposed amendment to the GCLMPO Board's Bylaws as requested by Mr. Hutchins at the March 23, 2017 Board meeting. In general the amendment creates geographic rotational Term Limits for officers. Section 4 entitled Terms of Office of the Board's bylaws was amended as follows:

The Chair and Vice-Chair term of office shall be one year with successive terms permitted. When the Chair is elected from a member local government from either Cleveland, Gaston or Lincoln counties, the Vice Chair shall be elected from a member local government from one of the other two counties. The Officers shall hold office no more than two consecutive Terms. Upon completion of two consecutive terms, a new Chair shall be elected from one of the other two counties.

Mr. Hutchins motioned to approve the Bylaws amendment as proposed. Mr. Toomey seconded the motion and the motion passed unanimously.

8. FY 2017 – 2018 Unified Planning Work Program (UPWP)

Mr. Graham explained, the proposed FY 2017-2018 GCLMPO UPWP to the Board. He stated that the UPWP outlines MPO work to be completed by task code category and it also includes the dollar amount budgeted for each task code for the year and the funding source for these tasks by agency.

The total proposed UPWP budget is \$500,999.00 and is comprised of \$414,694.00 in Transportation Planning (PL) grant funds, \$93,750.00 in State Planning and Research (SPR) funds, and \$39,000.00 in Transit Planning (Section 5303) grant funds. The MPO member

governments will be responsible for providing 20% local match for PL funds and SPR funds, and Gastonia will be responsible for the 20% match for 5303 transit planning grant funds. The invoices for local match will continue to be sent out quarterly. Please note these totals may change, as the FHWA and FTA have not yet provided official allocations for FY 17-18.

Mr. Graham stated that the additional funds needed for Special Studies would be funded with unobligated PL dollars from other MPO's statewide that do not spend their annual allocations. The unobligated fund balance is approximately 1.5 million dollars. Mr. Graham further explained that the additional Special Studies listed in Table 3 of the UPWP to be funded with Transportation Planning (PL) grant funds would not be subject to the overall local match cost sharing calculations and would only be funded by the affected jurisdictions. There will be funds for special studies, totaling \$40,000.00 for on-call Engineering Services as needed. Mr. Hutchins asked staff to distribute the rankings of the proposed Special Study projects to the Board as information.

Mr. Amaya motioned to approve the Bylaws amendment as proposed. Mr. Hamrick seconded the motion and the motion passed unanimously.

9. 2017 Project Schedule Coordination

Ms. Gates stated that the GCLMPO needed to complete the following tasks by August 2017:

- 1. Adopt a 2045 MTP fiscally constrained project list
- 2. Adopt the 2018-2027 TIP, approve 2040 MTP amendments and an air quality determination
- 3. Determine the projects that should be evaluated in the 2020-2029 TIP development process (P5.0)

Because there are so many concurrent processes, GCLMPO staff developed a detailed task schedule as information to better clarify and lay out these processes for both TCC and MPO Board Members.

10. Draft 2018-2027 TIP

Ms. Gates stated that since the release of the Draft 2018-2027 TIP, GCLMPO staff has thoroughly reviewed the proposed projects and schedules and has participated in multiple interagency consultation meetings. Amendments to the GCLMPO 2040 MTP are required in order for the MTP and TIP to be consistent based on the TIP's anticipated adoption in August 2017.

She also stated that an air quality conformity determination is required due to the Clean Air Act's requirement that all affected MPO's plans and programs conform to the purpose of the state implementation plan (SIP) for achieving air quality standards. Conformity to the purpose of the SIP means that the transportation activities will not cause new violations of the National Ambient Air Quality Standards (NAAQS), worsen existing violations, or delay timely attainment of the NAAQS.

A 30-day public comment period is scheduled from June 19 – July 19, as agreed to as part of the interagency consultation with our regional MPO partners, NCDOT, the NC Division of Air Quality, EPA, and FHWA.

Mr. Humphries motioned to approve the Draft 2018-2027 TIP, the 2040 MTP Amendments, and an air quality conformity determination report and a 30-day public comment period from June 19 to July 19, 2017. Mr. Amaya seconded the motion and the motion passed unanimously.

11. 2045 Metropolitan Transportation Plan (MTP) Update

Ms Gates explained that the GCLMPO is required to update its long-range transportation plan, known as a Metropolitan Transportation Plan (MTP), by May 2018. The proposed 2045 MTP will replace the existing 2040 MTP, which was adopted in March 2014. This document will detail existing and projected conditions in the three counties, establish goals, objectives, and policies, project and assign fiscal resources, and identify projects to meet objectives of the GCLMPO. Due to our status as Maintenance for Ozone, this plan must be shown to maintain air quality levels.

Prior activities have included:

- 1. The GCLMPO Board met on March 23, 2017 and reviewed and approved the Draft Goals, Objectives, & Policies for release for public review and comment.
- 2. The public comment period to solicit projects for the MTP, as well as to receive comments on the Draft Goals, Objectives, and Policies was held from April 1 April 30, 2017.
- 3. Three separate public workshop opportunities for the general public to review the Goals, Objectives, and Policies, as well as to comment on the current transportation projects list (from current MTP) and any other projects they feel need to be added for the 2045 MTP Update were held on April 12, April 13, and April 20, 2017.

Upcoming activities include:

- 1. Approval of the 2045 MTP Goals, Objectives, and Policies at the May TCC and MPO Board meetings.
- 2. Approval of the 2045 MTP Project Solicitation and Ranking Process at the May TCC and MPO Board meetings.
- 3. GCLMPO Staff will be ranking projects (all modes) through June 2017.
- 4. Approval of financial assumptions at the July TCC and MPO Board meetings.
- 5. Approval of Fiscally Constrained Project List for public comment at the July TCC and MPO Board meetings.
- 6. 30-day Public Comment Period for Fiscally Constrained Project List will be held August 1 30, 2017.
- 7. Approval of Fiscally Constrained Project List at the September TCC and MPO Board meetings.

Mr. Hutchins motioned to approve the 2045 MTP Goals, Objectives, and Policies with the removal of the Catawba Crossings project reference on page 90 of the agenda package. Mr. Fraley seconded the motion and the motion passed unanimously.

Mr. Humphries motioned to approve the 2045 MTP Project Solicitation and Ranking Process. Mr. Permenter seconded the motion and the motion passed unanimously.

12. Catawba Crossings Resolution of Support

Mr. Graham presented information on the Catawba Crossings thoroughfare. He stated that regional discussions have taken place regarding the need for an additional bridge in southeast Gaston County to provide additional connectivity to Mecklenburg County. The Catawba Crossings project as proposed is aptly named as it transverses both the Catawba River and the South Fork Catawba River beginning at NC 279 (New Hope Road) in Gaston County to West Boulevard at Interstate - 485 in Mecklenburg County.

The Catawba Crossings project is a major project in the Charlotte Metropolitan Region and should be appropriately ranked and prioritized as a Regional Tier project in P5.0. The Strategic Transportation Investments Law (STI) mandates that the Catawba Crossings project must have

an assigned US Route or NC Route number to be ranked and prioritized as a Regional Tier project.

The Board conducted a lively discussion over the benefits and prioritization considerations of the Catawba Crossings project.

Mr. Turner motioned to approve the Catawba Crossings Resolution requesting NCDOT to assign a US or NC Route number to the roadway as presented. Mr. Koutsoupias seconded the motion and the motion passed. There were 4 no votes (Amaya, Hamrick, Hutchins, Permenter, Toomey).





Subject: 2045 MTP Financial Assumptions

BACKGROUND:

The Federal Highway Administration (FHWA) requires a financial plan as part of the Metropolitan Transportation Plan (MTP). The MTP covers all modes of transportation and must be fiscally constrained in the context of anticipated future transportation revenues.

Financial Assumptions for the 2045 MTP have been developed by MPO staff in consultation with NCDOT and adjacent MPOs. These assumptions will be used to create fiscally constrained project lists for the 25-year MTP by established horizon years:

- 2018-2025
- 2026-2035
- 2036-2045

The following assumptions have been included:

- TIP revenue assumptions provided by NCDOT
- Estimated GCLMPO population numbers were used to determine the percentage of available funding for each STI funding category (Regional or Divisional).
 - NC Budget and Management 2015 Standard Estimates were used to update population shares in the 2045 MTP
- 2% annual inflation rate
 - It was verified that this is a reasonable approach with NCDOT, FHWA, and the other MPOs in the region





Subject: Prioritization 5.0 (P5.0) Update

BACKGROUND:

NCDOT uses a transparent, data-driven method for prioritizing transportation investment decisions. Through the process, called Prioritization, potential transportation improvement projects are submitted to NCDOT to be scored and ranked at the statewide, regional and division levels, based on approved criteria such as safety, congestion, benefit-cost and local priorities. These scores and other factors are used to determine whether a project receives funding.

At its May 25, 2017 meeting, the GCLMPO Board approved a transportation project ranking and prioritization methodology for transportation projects included in the Metropolitan Transportation Plan (MTP). It was understood at that time that the MTP methodology would also be utilized for P5.0 project submittal. By using a similar methodology for both MTP and SPOT projects, it will be easier to generate data-driven scores for all candidate transportation projects and the GCLMPO will know which transportation projects rank high enough for SPOT submittal.

The attached DRAFT P5.0 Project Submittal List includes projects for all modes that have scored the highest utilizing the approved ranking methodology. It is requested that Board members carefully review this DRAFT list to ensure that we are including the highest priority projects for your community and the MPO area. GCLMPO can submit 26 projects per mode (highway, bike/ped, aviation, and public transportation). GCLMPO staff will also be working with NCDOT Division 12 on projects that they may submit on our behalf.

NEXT STEPS:

- 1. MPO staff will continue to vet DRAFT P5.0 Project Submittals with TCC and Board members
- 2. MPO staff will coordinate with NCDOT Division 12 staff on potential project submittals
- 3. MPO staff will test potential project in SPOT On!Line to determine potential scores
- 4. GCLMPO TCC will review and recommend approval of the FINAL P5.0 Project Submittals at the September 13, 2017 TCC meeting
- 5. The MPO Board will receive public comment on P5.0 Project Submittals, as well as approve the project list at the September 27, 2017 Board meeting
- 6. MPO staff will submit projects through SPOT On!Line by the September 29, 2017 deadline

State Board of Elections and State Ethics Commission Merged into One New State Board

On June 1, 2017, a panel of superior court judges dismissed a lawsuit challenging the constitutionality of Session Law 2017-6, the <u>state law</u> creating the Bipartisan State Board of Elections and Ethics Enforcement (State Board). The new State Board merges the N.C. State Board of Elections and the N.C. State Ethics Commission and assumes duties formerly overseen by these two agencies, along with lobbying compliance carried out by the Secretary of State. Though parties to the lawsuit may seek additional review on appeal, for now, the consolidated State Board is the agency to enforce North Carolina's elections, ethics and lobbying laws.

Currently, the ethics staff and the election staff of the State Board are housed in different buildings. However, the goal is for all staff to be housed in one building by September 1, 2017. So, the ethics staff will be moving soon, but until then we will remain at our present location at 424 North Blount Street in Raleigh and our direct telephone number remains 919-814-3600.

Although the State Board is a new entity, the State Government Ethics Act (Ethics Act) remains in effect and applies to the same individuals as it did prior to this merger. The duties and obligations of the Ethics Act remain, including the *SEI filing requirements and the Ethics Education training requirements.* In addition, the duties of Agency Heads, including Board Chairs, and those of Ethics Liaisons remain the same.

Disclosure

The State Government Ethics Act requires the disclosure of financial and personal interests by most covered persons.

Public servants who are covered by the Ethics Act but who make less than \$60,000 per year, and ex-officio members of university and community college boards of trustees do not have to make these disclosures.

Due Dates

Initial Filing. Covered persons who are required to file an SEI must do so prior to their initial appointment, election, or employment.

Annual Filing. SEIs must be filed annually no later than April 15th.

Evaluations

The Commission evaluates the SEIs of public servants for actual and potential conflicts of interest between the public servant's public duties and private interests.

Penalties

The Commission may assess a \$250 civil penalty for late or non-filing. Criminal penalties apply to concealing information or providing false information.

Public Record

SEIs, including any attachments and evaluations are public record. HOWEVER, the Confidential Form used for providing the full names of Unemancipated (minor) Children, IS NOT A PUBLIC RECORD.

In addition, beginning in 2015, a filers CONTACT INFORMATION is being collected separately and will not be provided to the public as part of the online access to SEIs.

Federal fraud commission pauses voter data collection. No NC information has been sent.

The federal voter fraud commission is asking states not to send any voter information to Washington while a judge considers a request to stop the data collection.

North Carolina has not sent any voter information to the commission. It had planned to send information that is publicly available.

[NC is handing over some voter information to Trump's commission on voter fraud]

The Electronic Privacy Information Center is suing to stop the Presidential Advisory Commission on Election Integrity from collecting voter data. A federal judge held a hearing to consider a temporary restraining order last week. The presidential commission asked states' elections officials Monday not to send anything until the judge rules.

The request was sent to North Carolina's Bipartisan State Board of Elections and Ethics Enforcement. The federal commission also included it in a court document filed as part of

"Today, the Commission sent the states a follow-up communication requesting the states not submit any data until this Court rules on this TRO motion," commission vice-chairman Kris Kobach wrote in the court filing.

A letter from Kobach last month triggered a wave of protest. Though the letter asked for publicly available information, it included specific items that in many states are not public, such as partial Social Security numbers. The commission asked for the voter data by July 14.

The North Carolina elections board has received hundreds of calls and emails about its decision to send publicly available data. Some voters have asked to cancel their voter registration, which state officials are trying to discourage. The agency says it is required to provide the publicly available information under state law.

Some states have refused to send anything. U.S. Rep. Alma Adams, a Charlotte Democrat, asked the North Carolina elections board to join that group in a statement Monday.

"I urge the Board of Elections to reconsider compromising voter's privacy and security and refuse the commission's request in its entirety," Adams said.

NC elections office swamped with calls about voter data going to fraud commission

Some voters worried about a federal voter-fraud commission collecting information on them want to cancel their registration.

The state elections board has been deluged with calls over the last few days about how the state is handling a request from the commission for voter data – even though the board says it's handing over only information that's already available to the public.

Hundreds of people have called the Raleigh office of the Bipartisan State Board of Elections and Ethics Enforcement, and at least 380 people sent email, said board spokesman Patrick

Some of those voters - the office doesn't have a count - are asking to cancel their registration or for instructions how to do so.

"Kindly remove my name from NC voter rolls immediately. Thank you," one voter wrote Wednesday, adding that the commission "smells funny" and the people in charge could not be trusted.

President Donald Trump created the Presidential Commission on Voter Integrity by executive order in May. A letter that commission Vice Chairman Kris Kobach sent states in late June asking for information on voters, including partial Social Security numbers and felony convictions, sparked more controversy.

The state is not giving the commission all it has, just information that's already available to the public, board executive director Kim Westbrook Strach said in a statement.

That means the state won't hand over Social Security numbers, dates of birth, driver's license numbers and some of the other information people use to register.

Sixteen states and Washington, D.C., have refused to give the commission anything, with five still waiting to render their decisions. North Carolina is like others that are sending what's publicly available.

[States approach voter data request very differently]

Voter names, party registrations, addresses and voting histories are public information. Votes cast are private.

The board is trying to discourage people worried about the fraud commission from canceling their registration. Canceling now will not prevent information already in the database from going to the commission.

"The Bipartisan State Board of Elections & Ethics Enforcement has received phone calls and emails from voters who indicated they may cancel their registrations because of the recent federal request for voter data," Strach said. "Also, callers have inquired about how to go about canceling their registrations. We can't immediately say how many across the state have done so. Those requests are handled by the county boards of elections and the reason for any cancellation may not be known.

"The State Board would strongly discourage anyone from removing themselves from the rolls. The data to be made available to the Commission is publicly available to anyone at ncsbe.gov and has been for many years. This agency is required to provide it under state

law."

Dallas Woodhouse, state Republican Party executive director, said he would discourage voters from canceling their registration, unless those registrations are invalid.

"There are invalid votes being cast," Woodhouse said. "Every invalid vote being cast nullifies a good one. Each state has a hard time figuring out who is registered in other states. Some assistance from a federal authority could be helpful."

Bob Hall, executive director of the voting rights organization Democracy NC, called the June letter "a colossal blunder" and suspects that the commission's intent is to make people lose faith in the electoral process.

A North Carolina elections-board audit found that 508 ineligible voters cast ballots in 2016. More than 4.8 million voters participated in the election. The agency said the incidents weren't necessarily cases of voter fraud because voters may not have known they were
