**Subject:** 2045 MTP Amendment – FUSE Transfer Station

**BACKGROUND:** The City of Gastonia is planning for the development of the Franklin Urban Sports and Entertainment (FUSE) district. FUSE is an economic development and revitalization project designed to attract new commercial and residential development to the heart of the city. The hub of the project is a \$21.5 million, 5,000 seat capacity, multi-use sports and entertainment facility that will host year-round events and activities. The facility is adjoined and surrounded by private development parcels that will be home to restaurants, offices, apartments, condos, and entertainment venues.

Planning for the FUSE development has included the creation of a future **FUSE Transfer Station** at the intersection of Airline Avenue and Trenton Street. Current plans for this facility include up to three bus bays for secure passenger boarding and alighting, parking stalls, benches, trash receptacles, bicycle racks, and landscaping. The intent is to create a facility that is capable of being used for both regular fixed-route service, while also including future flexibility to serve game days and special events at the FUSE sports and entertainment complex. The FUSE Transfer Station would serve commuters, residents, students, visitors, and recreational users who desire an alternative way to travel to and from the city.

#### **PROJECT PURPOSE**

The purpose of the FUSE Transfer Station is to expand connectivity within the City of Gastonia by providing improved, high-quality, and cost-effective transit services that will address mobility needs for an expanding population and employment base west of downtown. Developing the FUSE Transfer Station also helps to address existing and anticipated transportation challenges.

Multi-modal transportation services will be enhanced by:

- Improving transit connectivity and ease-of-use in and around downtown Gastonia.
- Designing a functional, attractive, cost-effective facility that can meet near- and long-term projected service needs and be implemented in an expedient manner.
- Delivering a transit facility that is readily accessible to all transit users including individuals with disabilities and those whom are transit dependent.
- Providing a secure, safe, and inviting public space, and establishing convenient and clear pedestrian connections to surrounding land uses.
- Supporting local workforce development, job creation, retention, and community cohesion by enhancing multi-modal options in the City of Gastonia.

In order for federal funding through Gastonia Transit's 5307 Urbanized Area Formula Grant to be used for this project, the project must be included in the GCLMPO's 2045 MTP. In adherence to the GCLMPO's Public Participation Plan, a 30-day public comment period was held December 3, 2020 – January 1, 2021. **No public comments were received.**

**BACKGROUND:** In the long range transportation planning process, goals describe characteristics of the desired future transportation system for the area and objectives identify steps that are expected to achieve the goals. The goals and objectives inform the process by which projects are prioritized as well as the evaluation of the performance of the transportation system.

Metropolitan Planning Organizations (MPOs) are required to consider certain factors in the transportation planning process, of which the Metropolitan Transportation Plan (MTP) is a key element. GCLMPO staff have developed a set of draft goals and objectives that address the ten factors referenced in specific sections of Title 23 (FHWA) and Title 49 (FTA) of the Code of Federal Regulations, while also considering the characteristics of the GCLMPO planning area. To ensure cohesiveness on the overall future vision in the Metrolina region, GCLMPO staff coordinated with the staff of partner MPOs in the region regarding the goals. The TCC MTP Subcommittee and the Bicycle and Pedestrian Advisory Committee (BPAC) discussed the draft goals and objectives in December and the current draft (attached) reflects their comments and suggestions.

**BACKGROUND:** During the transportation planning process, many needs are identified for multiple modes, and as funding is always limited, the needs must be prioritized. Criteria used in the project ranking process help the MPO identify which projects are expected to effectively address the goals for the future transportation system. After projects are ranked, the MPO will need to allocate expected levels of future funding to a subset of the ranked projects.

For use in the development of the 2050 Metropolitan Transportation Plan (MTP), MPO staff developed proposed ranking methods for each mode. Generally, the ranking methodology that was applied for the 2045 MTP was used as a starting point. Based on past experience in applying the 2045 MTP ranking methods and submitting projects in the state's most recent round of prioritization, as well as consideration of the draft 2050 MTP goals and objectives, MPO staff have made a few revisions to create the proposed 2050 MTP Ranking Methodology.

After an MTP project ranking methodology is approved by the MPO Board, staff will apply it to the draft project lists in order to present prioritized project lists to the TCC and MPO Board in the spring.

**BACKGROUND:** The GCLMPO assesses transportation needs in a continuous, cooperative, and comprehensive manner. When updating the Metropolitan Transportation Plan (MTP), the MPO, in coordination with the state, local governments, multiple types of transportation agencies, and members of the public, identifies projects that are expected to address the needs and bring the multi-modal transportation system closer in line with the desired state described in the chosen set of goals. Other prior processes, such as the development and amendment of the Comprehensive Transportation Plan (CTP) and the prioritization of projects for the next State Transportation Improvement Program (STIP), help the MPO maintain awareness of the needs of the area.

GCLMPO staff have drafted 2050 MTP project lists for each mode through the following method:

- MPO staff reviewed the 2045 MTP in order to retain prior identified needs that have not been completed, including funded projects in the MPO's 10-year Metropolitan Transportation Improvement Program (MTIP);
- Staff then added other projects that had been submitted in 2020 during the most recent prioritization process ("P6.0"), under the NCDOT Strategic Transportation Investments (STI) law.

The resulting draft lists are being presented to the TCC and MPO Board for review and comment. At a subsequent meeting, a prioritized list will be considered for approval before fiscal constraint is applied.

#### **Public Participation**

As the draft projects lists for the 2050 MTP are a result of multiple prior initiatives, public participation has occurred for the development of the lists at several different stages, and future opportunities will be provided before the 2050 MTP is adopted.

Legacy projects from the 2045 MTP have been subject to public review and comment, in accordance with the MPO's Public Participation Plan, before the 2045 MTP was adopted in 2018 and during amendments thereafter. In addition, during the subsequent development of project lists for the "P6.0" Strategic Transportation Investments prioritization process, GCLMPO again solicited project needs from member governments, area agencies, and members of the public.

In 2020, the MPO TCC and Board reviewed the draft project lists and released them for a 30-day public comment period, including public meetings and an online map that allowed comments to be geographically marked. The MPO issued press releases in newspapers of general circulation in Cleveland, Gaston, and Lincoln counties soliciting input on the lists. The MPO also held a public input session in each of the three counties in February of 2020. Information regarding the public input sessions and this solicitation period was also advertised through the MPO website, social media, and through postings at member agencies.

**BACKGROUND:** The proposed FY 2021-2022 GCLMPO UPWP outlines MPO work to be completed by task code category. It also includes the dollar amount budgeted for each task code for the year and the funding source for these tasks by agency.

The total proposed UPWP budget is \$547,586.00.00 and is comprised of \$394,611.00 in Transportation Planning (PL) grant funds, \$93,750.00 in State Planning and Research (SPR) funds, and \$59,225.00 in Transit Planning (Section 5303) grant funds. The MPO member governments will be responsible for providing 20% local match for PL funds and SPR funds, and Gastonia will be responsible for the 10% local match for 5303 transit planning grant funds, an additional 10% match comes from the state. The invoices for local match will continue to be sent out quarterly. Cost share allocation tables are attached.

**BACKGROUND:** Since FY 2018-2019, member jurisdictions have been invoiced for MPO Board Meeting meals. Food is not an eligible expense for the MPO's 104(d) or SPR grants, and therefore cannot be reimbursed. It is requested that the cost of meals continue to be divided equally among the member jurisdictions.

The meals typically cost \$400 or less per meeting. There is estimated to be up to eight (8) MPO Board meetings in FY 21-22 and there are 17 voting member jurisdictions. Rounding up, if every member jurisdiction agrees to pay up to a total of \$190 each in FY 21-22, this will cover all MPO Board Meeting meals (if meetings are in person).

Actual costs per quarter will be equally divided among the voting member jurisdictions and will be invoiced quarterly along with the local match amounts for the grant. If meetings continue to be virtual, there will be no charges for meals.

#### ANNOUNCEMENT FOR THE START OF THE CATAWBA CROSSINGS FEASIBILITY STUDY

The Gaston-Cleveland-Lincoln Metropolitan Planning Organization (GCLMPO) and regional project sponsors have begun a feasibility study for the Catawba Crossings Project. A feasibility study is an early planning tool that results in conceptual designs, cost estimates, and recommendations for future study.

The Catawba Crossings Project proposes a new alignment roadway between NC 279 (S. New Hope Road) in southeastern Gaston County to NC 160 (Steele Creek Road) in western Mecklenburg County. The GCLMPO recommends a multi-lane, median-divided boulevard. A boulevard typically includes landscaping along the roadway as well as bicycle and pedestrian accommodations.
